Agenda Item and Comments

03/21/179 – Minutes of the Previous Meeting

The minutes of the previous meeting held on Wednesday 1st October were read and accepted as a true record. This was proposed by Councillor Rowlands and seconded by Councillor Clifford.

03/21/180 – Matters Arising

A summary of the October Action Plan:

03/21/181 Police & Neighbourhood Watch Matters

PC Andy Griffiths – PC 124 – attended from the Pill Area (this covers Duffryn, Castleton, Marshfileld). He can be contacted on 01633 245318.

PC Griffiths commented that his focus in the area was on Crime Prevention and in particular, Antisocial Behaviour, a current problem in Marshfield. He believes that problems can be tackled more easily with good intelligence provided by the local community. He believes that wider powers of enforcement i.e. Antisocial Behaviour Orders can work in our community. He urged the community to report incidents, particularly the taking of car number plates of those causing a nuisance on our roads.

Councillor Evans pointed out that vehicle and scrambler bikes are a continuous nuisance in Michaelston-Y-Fedw. He suggested that due to the low Police presence in our area, a private security firm could be employed by residents to patrol our country lanes during the night. At this point, PC Griffiths brought to the Council's attention the "Ranger" scheme operated by Newport County Council, which offers patrols in certain areas.

Action: Clerk to contact Cllr Tony Boswell for information on the service and to invite a Ranger to the next Community Council meeting.

03/21/1182 Planning

One planning application was received:

1. Cefn Mably Farm Park, Began Road - Retention of residential caravan in conjunction with the operation of Cefn Mably Farm Park. CONEX/03/1425. The council strongly discourages retrospective planning applications like this, and objects to the presence and size of this caravan.

Action: Clerk to write to Council.

03/21/183 Roads – Hedges – Verges and Bridges

Roads – Notice given of road re-surfacing in our area, starting on Began Road for week commencing 17th November. Cllr. Evans raised the access concerns of the Landlord of the Cefn Mably Pub. However, the Council (in their opinion) believe it would not be affected, as there would be access from at least one direction.

Hedges – Generally the maintenance of hedges is carried out regularly. However, Cllr Evans brought it to the Councils attention that the quality of cutting was extremely questionable in the case of the row of conifers near to Five Oaks, Druidstone Road. All agreed that the severity of the cut had possibly damaged the trees beyond reasonable regrowth.

Bridge – The Bridge bordering Caerphilly Boundary continues to be a problem. Chairman noted that whilst Caerphilly Council had laid a red warning sign on the road, advising motorists of the narrowing of the road over the bridge, it continued to be hit on a regular basis. Chairman suggested that bollards needed to be placed on the approach to the bridge. Cllr. Rowlands advised the Clerk that correspondence on the history of the bridge should be on file.

- Action: Clerk to write to contact provided by Father. John Dale, noting the damage to the conifers, and copying to Cllr. Tony Boswell.
- Action: Chairman to advise the Clerk on the name of the Bridge Engineer at Caerphilly Council. Clerk to arrange an on-site meeting with Chairman, Tony Boswell and the Engineer at the bridge to discuss the erection of bollards from the Caerphilly side.

03/21/184 Correspondence
