## **Agenda Item and Comments**

### **05/01/047 – Minutes of the Previous Meeting**

The minutes of the previous meeting held on Wednesday May 4<sup>th</sup>, 2005 were read and accepted as a true record. This was proposed by Councillor Clifford and seconded by Councillor Rowlands.

### **05/01/048 – Matters Arising**

**Roads** – Councillor Huckle thought it unnecessary to have a sub-committee as herself and the Clerk could more easily draft a letter to accompany the photos. The Clerk had walked Druidstone Road and Tyler Lane taking over 50 photos of the appalling pot-holes that all averaged a 3” plus depth. These would be sent with the letter to the Head of Highways.

**Action: Councillor Huckle and Clerk to draft**

Councillor Morgan and Percy stated that they continued to lobby on behalf of rural roads at every opportunity.

Councillor Rowlands phoned the Council Hotline and the pot-holes on Began Road

were filled. It would seem that when reported they were filled, but this didn't detract from the on-going need for total re-surfacing.

**BT Pole** – On-going issue with BT failing to remove the pole. Councillor Clifford said another car had collided with it. Councillor Phillips said he'd contact Newport Council so that they could press BT to sort out.

**Action: Councillor Phillips**

**“Children Crossing” sign** – Councillor Percy said that this now lay with the Planning Department of Newport Council, but that it would be erected in due course.

#### **05/01/049 - Police Matters**

There was no Police representative present. PC Neesam's replacement, PC 516 McAllister, has written to the Community Council advising that he will be in post the middle of June, and will make every effort to attend forthcoming meetings. In his absence, PC 599 Muirhead can be contacted.

#### **05/01/050 – Planning**

##### **CONEX: 05/0555 Construction of Noise Attenuation Bund (Re-submission) at 5 Oaks, Michaelston-y-Fedw.**

**Decision:** It was noted by the Community Council that the new submission is now in line with the Community Council's original view, and subsequently that of the WAG Inspectorate, that the original size bund was too large. This new bund is substantially smaller, and therefore acceptable.

##### **CONEX: 05/0678 Erection of Barn at Cefn Mably Farm Park**

**Decision:** No objection

##### **CONEX: 05/0678 Erection of Porch at Druidstone Cottage, Druidstone Road, Michaelston-y-Fedw**

**Decision:** No objection as it is replacing the old porch, although slightly bigger.

#### **05/01/051 - Roads – Hedges – Verges and Bridges**

There were no new issues. All currently being dealt with under Matters Arising.

#### **05/01/052 - Correspondence**

**Various Correspondence was received, including:-**

**Brochures on Play Equipment** - Councillor Huckle is very interested in creating a play area within the confines of the village hall (preferably on the grass area) for the children of the village. She stressed that there is no play area provision for local children currently. Councillor Rowlands suggested that Councillor Huckle and the Clerk present a proposal to the next meeting with costings, Health & Safety implications, insurance provision etc.

**Bassaleg School** – The Chairman advised that cars were now prohibited from entering the school grounds. Cars were now parking on the road outside of the school, causing a hazard to both motorists and pedestrians.

**Tirzah Baptist Chapel** - Councillor Phillips stated the need to trim the graveyard. He will get quotes from companies willing to undertake the work.

**Action: Councillor Phillips to get quotes**

**Weight Limit Signs** - Councillor Phillips said that these signs (approaching his farm but within Graig Ward) are causing problems for deliveries. The signs do not have “accept for access” on them. Lorries trying to deliver to his farm are unable to access his farm.
