Agenda Item and Comments

05/01/019 – Minutes of the Previous Meeting

The minutes of the previous meeting held on Wednesday February 2nd 2005 were read and accepted as a true record. This was proposed by Councillor Rowlands and seconded by Councillor Walford.

05/01/020- Matters Arising

Rural Roads Action Group – Councillor Morgan stated that £170m of extra funding was being made available to Newport City Council Highways Department. He had written to the Argos deriding the state of rural roads, and requesting that a proportion of this new money be spent on the rural communities. However, Councillor Morgan has been told that this money is to be spent in the town and on major carriageways.

Action: Councillor Morgan will continue to lobby on this issue.

Drains – It can be positively reported that the road from MYF to Bassaleg, has had its drains cleared 3 times in as many months. However, Councillor Rowlands stated that the Began Road still had blocked drains.

Action: Clerk to phone hot line

BT Utility Pole - Cllr. Phillips has spoken to BT, and given precise location of the pole. BT will now remove it.

"Children Crossing" sign – Councillor Huckle continues to lobby for this road sign to be placed at the lower end of the village, where 3 school buses pick up/drop off. Action: Councillor Pursey to brief Councillors of his progress at the next meeting.

Community Litter Day – This has been re-scheduled for Sunday, April 17th. **Action:** Event organisation to be arranged at April meeting.

Bank – Clerk to draft a letter to the bank requesting that they pay interest gross, and that tax previously deducted should be reclaimed.

Donation – Councillor Morgan has volunteered a donation of £200 towards the cost of refurbishing the Village Hall.
