Agenda Item and Comments

04/08/01 – Minutes of the previous meeting.

04/08/08 – Meeting Reports Liaison Meeting

Councillor Rowlands attended the liaison meeting and reported back to the Community Council. The two items that Michaelston Y Fedw requested were on the agenda: Planning Enforcement and the state of rural roads. However, due to no one from the planning department being present planning enforcement was not discussed. It was agreed that it would be carried over to the next meeting. On the matter of rural roads a specification sheet was presented as to the requirements of a pothole to warrant repair. It was claimed most urgent potholes should be repaired within 24hrs and the least urgent in 21 days. It was admitted that the Council cannot cope with the state of the roads and there is no money to keep up with the repairs. Cllr. Rowlands had asked how much money was being spent on paying insurance claims as a result of the state of the roads, the answer was half a million pounds. It was agreed that all the Community Council can do is to keep reporting the potholes and keep complaining about the state of the roads

The concurrent expenditure of Community Council's was also discussed; we have received a 1.8% increase above last year, resulting in £1200 for 2008/09. But how is the amount calculated? It was agreed that a working party is going to be set up allowing only one Councillor per Community Council to look at how the money is allocated and spent.

04/08/09 – Chairman's Business Litter Pick

It was agreed that the litter pick would go ahead in April as in the previous year and that a newsletter was needed to inform the community of this and the proposed river clean. Cllr. White very kindly donated £100 from Newport City Council towards the cost of the litter pick.

Action: Clerk and Cllr. Dixon to arrange a date.

At the end of the meeting Cllr. Pursey announced his retirement and that this was his last meeting for Michaelston Y Fedw Community Council. The Community Council wished to thank Cllr. Pursey for all his time and support.
