## **Agenda Item and Comments**

### **01/15/01 – Minutes of the previous meeting.**

The minutes of the previous meeting held on Wednesday December 3<sup>rd</sup> 2014 were proposed by Cllr. Walford and seconded by Cllr. Morgan.

### **01/15/02 – Police Matters**

There were no police matters to report.

### **01/15/03 – Matters Arising**

The repairs to the Millennium bench are going ahead and Cllr. Walford presented the quote for the notice boards. £141.50 plus VAT for the board by the village hall and £114.00 plus VAT for the one up on Penylan. All were in agreement that the work should go ahead and the quote was acceptable.

Cllr. Walford has drafted a letter concerning the renaming of Penylan.

### **01/15/04 – Planning**

**Fairwater Farm** – there is no news on this application.

**Clearwell Farm** –Cllr. Davies read out an email to the Council from applicant Mr. D. Phillips (who was present at the meeting) Mr. Phillips is having new photographs taken of the North West Viewpoints -

- 1 The footpath adjacent Cae Gwyn/ Graig View
- 2 Public Highway in region of Holly tree/Yew tree cottage
- 3 Public Highway near Minorca cottages.

He asked if the Council would be satisfied with these and a Councillor would be welcome to accompany the architect on his visit.

Also, Mr. Phillips informed the meeting that contractors would be starting work on Tinkers Field to install hedges and trees to slow rainfall and reduce flood risk.

**Action: The Chairman thanked Mr. Phillips for his information.**

## **01/15/05 – Roads, Hedges, Verges and Bridges**

Cefn Llwyd Bridge has still not been repaired; Cllr. Rowlands spoke to Caerphilly Council again this week and has been informed that the work to repair the bridge has been commissioned but no start date has been set as yet. Caerphilly is going to speak to Highways about the possibility of using bollards to prevent damage occurring in the future.

**Action: Cllr. Rowlands to speak to CADW if there is no response from the Council as the bridge is listed.**

Cllr. Meringolo discussed the recurring problem of water running down Pentrepoeth Road into the village. The Drains need unblocking and many of the drains are above the surface of the road and therefore do not work.

**Action: Cllr. Meringolo to continue with this issue.**
