The Community Council noted the planning appeal but had no comments to make.

NB: Cllr. Phillips was not present when this item was discussed.

Development Plan – Cllr. White had informed Cllr. Rowlands that the preferred strategy agreed by Cabinet included that "the existing green belt be maintained and extended"

Within the new LDP Marshfield could remain within the green belt and that it would be extended up to the M4 boundary. Although nothing has been finally agreed and could be subject to change before the LDP is finalised. Michaelston is to remain open countryside.

01/10/05 - Roads, Hedges, Verges and Bridges

Cllr. Phillips complained about the state of the roads during the bad weather and the fact that the Council had not been clearing the roads or gritting them very often. It was also noted that there has not been enough grit and most of the bins are empty. There have also been several cars crashing at the bridge as they are slipping on the ice and snow.
