Cllr. Meringolo reported that another site meeting would be needed as the slabs that have been placed around the manholes are too long and are causing further problems; he dug the drains out himself over the Christmas period.

Cllr. Rowlands pointed out the appalling state of Began Road and how dangerous it has become with all the loose gravel now compiling at the bottom of the hill. This was the only road that was not resurfaced in the village.

Cllr. Davies noted that there had been another accident at Castleton, the junction is extremely dangerous and water from the fields is collecting at the central reservation. It was also pointed out that the footbridge is not suitable for wheelchairs, making it impossible to cross the road safely.
