Cllr. Rowlands attended the liaison meeting and there appeared to be two main issues. Firstly, how the concurrent funds are allocated. It was debated how it should be decided that the money is given to Community Councils and how it should be spent. Secondly, the issue of Gypsy and Traveller sites was hotly debated. Lucie Taylor from Newport City Council informed the meeting that 11 sites have been chosen from a list of 240 sites. The Community Councils appeared very annoyed that they had not been asked initially on this consultation process. Cllr. Rowlands pointed out the Michaelston Y Fedw already has two separate Gypsy sites in the village.

The wreath that is laid at the Remembrance Sunday service needs to be located and it was agreed that instead of buying a new wreath every year it would be more sensible to make a donation instead. All were agreed that a donation of £25 was appropriate.

Community Councillors

Cllr. V. Davies informed the meeting that many local residents have questioned him regarding the role of the Community Councillors. They seem to be unsure as to what the Councillors can offer the Community or what help they can provide. It was agreed that a poster could be displayed in the pub with names of the Councillors, City Councillors and telephone numbers and useful numbers for Newport City Council to report common problems e.g. potholes, fly tipping etc. It was also considered a good idea to gather email addresses from local residents so a quarterly newsletter could be sent out to keep people updated with Community issues, news and events.
