Samantha Kremzer, Senior Planning Officer (Policy) from Newport Council gave an outline of the process and current thinking regarding the Local Development Plan update. The current plan runs until 2026 and the update will set out the strategy beyond that. They are currently looking at Candidate Sites submitted by landowners, with a view to selecting sites where more than 10 houses could be developed. It seems unlikely that any such sites would be in the Michaelston-y-Fedw area because of its remoteness from infrastructure and transport services. Next steps will be to consider growth options and then the preferred strategy, both of which will involve public consultations. Welsh Government have declared SE Wales as a National Growth Area but with Green Belt to the North and West of Newport. The Green Belt map lacks detail so currently it is impossible to tell how it relates to Michaelston-y-Fedw. However, the existing green belt will remain in place and there is no desire to allow Newport and Cardiff to become conjoined.

 Councillors discussed the issue of vehicles speeding on local roads which is causing danger to road users in the village. There is only a 60mph national speed limit, so speed cameras and speed bumps cannot be used. The council will raise this with the police when they visit the village in May and will investigate the cost and legality of installing electronic speed warning signs.
