

**NEWPORT CITY COUNCIL
(DRUIDSTONE ROAD, NEWPORT)
(TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2021**

NOTICE is hereby given that Newport City Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends, not less than 7 days from the date of this notice to make an order the effect of which will be to prohibit any vehicle from proceeding along Druidstone Road from its junction of Ty – Winch Road to its junction with Tyla Lane.

The alternative route is via Coal Pit Lane – A48 Newport Road – Wern Fawr Lane – Tyr Winch Road.

The reason for making the order is to allow gas mains replacement as road width is too narrow to allow passing traffic whilst undertaking excavation works. The proposed order will be operative from 07 June 2021 and will continue in force for a period not exceeding 18 months or until the works which it is proposed to carry out have been completed, whichever is the earlier. It is anticipated that the works will be completed by 09 August 2021. Pedestrian access will be maintained at all times. Emergency vehicle access will be **not** be available and the alternative routes should be followed
