04/17/01 - Minutes of the previous meetings

- The minutes of the 1st March meeting were proposed as correct by Councillor Rowlands and seconded by Councillor Walford.
- Councillor V. Davies pointed out that he had given his apologies for the meeting but they were not recorded in the minutes.

04/17/02 - Matters arising

- Councillor Walford is liaising with Mr C Edwards regarding strengthening the grass areas of the Village Hall car park.
- CCTV has been installed, configured and paid for. The system will be registered under the Data Protection Act; Councillor G. Davies will act as system controller for that purpose.
- Regarding the condition of trees at Bridge Terrace, Newport City Homes have said that they will be carrying out a survey and will take remedial action if necessary.
- The remains of last year's wild flowers opposite Began Road junction have now been sprayed off.

04/17/03 - Police matters

• The monthly police report for March was circulated at the meeting. There were two burglaries and an attempted vehicle break-in reported in Michaelston-y-Fedw.

04/17/04 - Planning

• Councillors Rowlands, G. Davies and Walford attended a public meeting about the proposed waste transfer station at Pentrepoeth Road. There was strong feeling against the proposal and Michaelston-y-Fedw Community Council has registered an objection to the scheme.

04/17/05 - Correspondence

- One copy of The Good Councillor Guide has been received; the council must print any additional copies needed at its own expense.
- A list of One Voice Wales training modules for councillors has been received this will be useful for new councillors from May 2017.

04/17/06 - Finance

- Newport Council has confirmed that the expected Precept and Concurrent grant will be paid.
- The 2016-17 accounts have now been closed. An income / expenditure statement was circulated at the meeting.
- Because of difficulties in using the free software on the council's laptop, councillors agreed to purchase a copy of Microsoft Office.
