# 12/18/01 - Minutes of the previous meeting

 The minutes of the November meeting were proposed as correct by Councillor Walford and seconded by Councillor Davies.

#### 12/18/02 - Matters arising

- Road safety on A48. No further progress since Councillor Hallett met with Marshfield Community Council last month. A further meeting is expected after Marshfield CC's next meeting on Tuesday. It was noted that traffic seems to be coping with the temporary 30mph speed limit, bolstering the idea that a permanent 30 or 40pmh limit would be workable.
- The water running across the road near Reservoir House appears to have been stopped.

#### 12/18/03 - Police matters

- The monthly police report hasn't yet been received. It will be circulated to councillors by email when received.
- The Gwent Police & Crime Commissioner has written to say that he is considering asking for an increase in the police precept of £1 per month for a Band D property. An on-line consultation will be running until the 13<sup>th</sup> January 2019 the Clerk will put a link on the community council web page.

### 12/18/04 - Planning

- No new applications received.
- It was noted that the waste disposal operations at Croescarneinon Farm seem to be coming to an end.

# 12/18/05 Roads & Rights of Way

#### 12/18/06 - Correspondence

- Welsh Government is planning to develop a package of resources to help local councils increase their use of the Welsh language.
- HMRC will be carrying out an Employer Compliance Review of this community council in January.

#### 12/18/07 - Finance

 Newport Council has decided to withdraw the Concurrent Grant from all community councils from 2019. This grant currently amounts to about 25% of this community council's income, with the remainder coming from the Council Tax Precept. Councillor Hallett will attend the Newport Community Councils Liaison Meeting on December 6<sup>th</sup> to join other community councils in protesting at the lack of consultation or warning before making this change.

Councillors drafted a budget for 2019-20 on the assumption that this funding will be withdrawn. This budget will be finalised at the January meeting when a decision will be made as to whether to seek an increase in the precept to compensate for the loss of the grant.

- Income and expenditure for the current year was reviewed and is proceeding as expected.
- Councillors resolved to increase the Clerk's salary from £660 to £1000pa to comply with National Minimum Wage legislation.

#### **12/18/09 – Other Business**

- After considerable delay, Newport Council has now replaced the damaged roadside grit bins, as requested by the community council.
- A community litter pick will take place on Saturday 12<sup>th</sup> January.
